YOUR RIGHTS

Within the scope of Article 11 of the KVKK, provided that you prove your identity;

- You can find out whether we process your personal data, and if we process or have processed your personal data, you can request information about it.
 - You can learn the purpose of processing your personal data and whether they are used in accordance with their purpose.
 - You can find out whether your personal data is transferred domestically or abroad and to whom it is transferred.
- You may request the correction of inaccurate or incomplete personal data and the notification of recipients to whom such data has been or may have been transferred.
 - You can request the destruction of your personal data.
- You may request that the transactions carried out regarding the destruction and/or correction of your personal data be notified to third parties to whom your personal data has been transferred by us.
- You can object to the fact that your personal data analysis, which is exclusively generated using an automated system, has led to an unfavorable outcome for you.
- If you suffer damage due to unlawful processing of your personal data, you may request compensation for the damage.

Your requests in your application will be finalized free of charge within thirty days at the latest, depending on the nature of the request. However, if the transaction requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board in the Communiqué on the Procedures and Principles of Application to the Data Controller may be charged.

You can make your application regarding the processing of your personal data in the following ways, provided that

you comply with the conditions in Article 5 of the Communiqué on the Procedures and Principles of Application to the Data Controller:

- In writing and signedThrough your registered electronic mail (KEP)
- With secure electronic signature or mobile signature
- By clicking on the relevant application link on our website
- As the data controller, we may request additional verifications (such as sending a message to your registered phone number, calling you) to determine whether the application belongs to you.
